### **SECTION – I: INVITATION FOR BIDS**

E-tenders are invited from reputed, experienced, and eligible suppliers/manufacturers/authorized dealers for the **Supply**, **Installation**, and **Commissioning of a Commercial Treadmill** at Maharaja Agrasen College, University of Delhi, Vasundhara Enclave, Delhi-110096.

# **SECTION – II: SCHEDULE OF REQUIREMENTS**

Name of Item: Commercial Treadmill (1 Unit)

**Delivery Location:** Maharaja Agrasen College, University of Delhi, Vasundhara Enclave,

Delhi-110096

**Delivery Period:** Within 30 days from the date of purchase order.

**Warranty:** Minimum 2 years comprehensive onsite warranty on the entire unit, including motor, electronic parts, and running belt.

## **SECTION – III: ELIGIBILITY CRITERIA**

- 1. The bidder must be a **manufacturer** or an **authorized dealer/distributor** of the treadmill brand quoted.
- 2. The bidder must have supplied similar equipment (commercial treadmills/fitness machines) to at least one **Government/PSU/Educational Institutions** in the last 3 years (01.04.2022 to 30.09.2025).
- 3. The bidder should have a valid **GST registration** and **PAN**.
- 4. The bidder must not have been blacklisted by any Government Department/Organization.
- 5. Supporting documents to be uploaded:
  - Company registration certificate
  - Authorization letter (if dealer/distributor)
  - o Copy of supply order/work completion certificate
  - GST & PAN copy
  - Signed copy of tender document
  - Office address proof in Delhi/Service Center in Delhi with proof
  - o Brochure of the treadmill brand to be supplied with specification
  - Work satisfactory certificate from existing user(s)
  - o Undertaking in r/o Serial No.4 above (Not Blacklisted)

## SECTION – IV: TECHNICAL SPECIFICATIONS

The treadmill must comply with the following minimum specifications:

- 1. **Running Surface:** 25" x 67"
- 2. User Weight Capacity: Minimum 200 Kg
- 3. **Usage:** Heavy duty Commercial
- 4. **Motor:** AC Driving System with over current, short circuit protection function, 5 HP AC continuous (10.0 HP peak)
- 5. **Speed Range:** 1 25 kmph
- 6. **Incline Range:** 3–18%, with precise electronic control
- 7. **Display Console:** 
  - o 7 window bright LED display
  - o Parameters: Time, Speed, Distance, Incline, Calories, Heart Rate, Steps
  - o Direct speed & incline keys on the console
- 8. **Programs:** Multiple 24 motivating programs for varied workout requirements
- 9. Build & Suspension:
  - Extra heavy-duty steel base
  - o Double cell neoprene rubber suspension system
  - o 1" thick fibre board running deck
  - o German Siegling running belt

#### 10. Additional Features:

- o USB charging point
- MP3 connectivity with speakers
- o Sweat-proof console design
- Emergency stop button for safety
- o Equipped with an automatic lubrication system.

### 11. Maximum User Weight Supported: 200 Kg

Note: Bidders must provide product brochures/technical datasheets clearly showing compliance with the above specifications.

# **SECTION - V: TERMS & CONDITIONS**

- 1. **Rates:** The quoted rates shall be in **INR** and must be inclusive of all charges GST, packing, forwarding, transportation, loading/unloading, and installation at site.
- 2. **Delivery:** The supplier shall deliver, install, and commission the treadmill at the specified site within **30 days** of the Purchase Order.
- 3. Warranty & Support:
  - o Minimum 2 years comprehensive onsite warranty.

- o Availability of spares for at least **5 years** from the date of supply.
- o Service response time should not exceed **72 hours** from complaint logging.

### 4. Payment Terms:

 100% payment shall be released after successful delivery, installation, and acceptance.

#### 5. Penalty Clause:

o Delayed delivery shall attract penalty @ **0.5% of order value per week**, subject to a maximum of 10%.

#### 6. **Rejection:**

o If the supplied equipment does not meet tender specifications, it shall be rejected at the supplier's cost.

#### 7. **Jurisdiction:**

o Any dispute shall be subject to the jurisdiction of Delhi Courts.

### SECTION – VI: BID SUBMISSION

- 1. Bidders must submit their bids online at **CPP Portal** only.
- 2. The bid shall comprise two parts:
  - o **Technical Bid**: Compliance with eligibility criteria and technical specifications.
  - o **Financial Bid**: Price quoted in BOQ format provided on the portal.
- 3. **Bid Validity:** 90 days from the last date of submission.

## **SECTION – VII: EVALUATION CRITERIA**

- 1. Technical bids will be evaluated first. Only technically qualified bids will proceed for financial evaluation.
- 2. The contract will be awarded to the **lowest responsive bidder (L1)** meeting all eligibility and technical requirements.
